Slido uses cookies and similar technologies on the Websites, the Mobile App and emails (together "Service").

What are cookies

Cookies are small text files that are placed on your computer by websites you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site.

Cookies may be set by Slido ("first party cookies"), or by third parties, such as those who provide advertising or analytics services on the website ("third party cookies") either for a single visit (a "session cookie") or for multiple repeat visits ("persistent cookie").
