You might notice we have nevertheless kept references to Privacy Shield in addition to Standard Contractual Clauses despite it being invalidated as a sufficient transfer safeguard on its own. This is because it is still additional evidence of privacy compliance efforts. Additionally, we audit our service providers in accordance with the latest guidance to ensure we have sufficient supplementary measures in place. There may also be entities that process your personal data as a controller, such as the organiser's company, banks, payment services, accountants or auditors.
